

CONSENT AND LIABILITY WAIVER AGREEMENT

This Consent and Liability Waiver Agreement ("Agreement") is made between the undersigned candidate ("Candidate") and MeriAunty.com ("Company"), including its owners, employees, representatives, and affiliates (collectively referred to as "Meri Aunty"). 4. Release of Liability

5. No Legal Action Against Meri Aunty

The Candidate expressly waives any right to bring disputes before a court of law, including the right to participate in a class-action lawsuit against Meri Aunty.

7. Indemnification

The Candidate agrees to indemnify, defend, and hold harmless Meri Aunty from any losses, liabilities, costs, or expenses (including legal fees) that may arise due to the Candidate's actions, claims by third parties, or breach of this Agreement. Submission of profile (elaborate details as per the form) through the designated Google Form (link above) shall be deemed as direct and unconditional acceptance of all terms outlined herein.

11. Severability

If any provision of this Agreement is deemed invalid or unenforceable, the remaining provisions shall continue in full force and effect. Any modification or waiver of any provision must be in writing and signed by both parties.

By submitting their profile through the designated form, the Candidate acknowledges that they have read, understood, and voluntarily agreed to this Agreement. The Candidate affirms that they are at least 18 years of age and legally competent to enter into this Agreement.
